

BAC Resolution No. 0344, Series of 2025

Procurement and Delivery of Materials for Sustainable Livelihood Training on Muscovy Duck Raising

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement and Delivery of Materials for Sustainable Livelihood Training on Muscovy Duck Raising with an Approved Budget for the Contract (ABC) of Two Hundred Eighty-Three Thousand Nine Hundred Twenty Pesos Only (Php 283,920.00) for lot 1 and Forty-Three Thousand Eight Hundred Pesos Only (Php 43,800.00) for lot 2.

WHEREAS, on Mar. 6, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) THREE N' ONE ENTERPRISE; (2) KMK AGRI PRODUCTS TRADING; (3) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 13, 2025, THREE N' ONE ENTERPRISE, KMK AGRI PRODUCTS TRADING and ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC. is considered as the lowest offeror for lot 1 and 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC. in the amount of Two Hundred Seventy-Nine Thousand Four Hundred Forty Pesos Only (Php 279,440.00) is the lowest quotation for lot 1 and in the amount of Forty-One Thousand One Hundred Sixty Pesos Only (Php 41,160.00) for lot 2.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant. WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement and Delivery of Materials for Sustainable Livelihood Training on Muscovy Duck Raising to ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC. in the amount of Two Hundred Seventy-Nine Thousand Four Hundred Forty Pesos Only (Php 279,440.00) for lot 1 and in the amount of Forty-One Thousand One Hundred Sixty Pesos Only (Php 41,160.00) for lot 2.
