Procurement of PPE for Masagana Rice Development Program in Western Visayas

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of PPE for Masagana Rice Development Program in Western Visayas with an Approved Budget for the Contract (ABC) of Six Hundred Forty-Five Thousand Pesos Only (Php 645,000.00).

WHEREAS, on Mar. 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) YORO'S CONSUMER GOODS TRADING; (2) ARTJUANA DESIGNS AND PROMOS INC.; (3) HOMEPRINTS COMMERCIAL OPC; (4) BLACK FEATHER ADVERTISING

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 10, 2025, YORO'S CONSUMER GOODS TRADING, ARTJUANA DESIGNS AND PROMOS INC., HOMEPRINTS COMMERCIAL OPC and BLACK FEATHER ADVERTISING submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BLACK FEATHER ADVERTISING is considered as the lowest offeror. However, the suppliers submitted Omnibus Sworn Statement is unsigned and incomplete data. Therefore, considered as non-responsive.

WHEREAS, HOMEPRINTS COMMERCIAL OPC is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by HOMEPRINTS COMMERCIAL OPC in the amount of Five Hundred Forty-Three Thousand Pesos Only (Php 543,000.00) is the responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of PPE for Masagana Rice Development Program in Western Visayas to HOMEPRINTS COMMERCIAL OPC in the amount of Five Hundred Forty-Three Thousand Pesos Only (Php 543,000.00).
