WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Van Rental for Validation, Monitoring & other activities of Corn Program Implementation in the region with an Approved Budget for the Contract (ABC) of Twenty Two Thousand Five Hundred Pesos Only (Php 22,500.00) for lot 1 and of Twenty One Thousand Pesos Only (Php 21,000.00) for lot 2 and Fifteen Thousand Pesos Only (Php 15,000.00) for lot 3 and Twenty Six Thousand Pesos Only (Php 26,000.00) for lot 4 and Fifteen Thousand Pesos Only (Php 15,000.00) for lot 5

WHEREAS, on Mar. 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) EXECUTIVE ELEGANCE CHARTERS, OPC; (2) RJ TRANSPORT SERVICES; (3) BENNCH TRANSPORT SERVICES

WHEREAS, before the lapse of the deadline for submission of quotation at 3:00 PM. on Mar. 14, 2025, EXECUTIVE ELEGANCE CHARTERS, OPC; RJ TRANSPORT SERVICES and BENNCH TRANSPORT SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BENNCH TRANSPORT SERVICES is considered as the lowest offeror for lot 1, 3, 4 and 5 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, RJ TRANSPORT SERVICES is considered as the lowest offeror for 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval the award of contract for the Procurement of Van Rental for Validation, Monitoring & other activities of Corn Program Implementation in the region to BENNCH TRANSPORT SERVICES in the amount of Eighteen Thousand Nine Hundred Pesos Only (Php 18,900.00) for lot 1 and in the amount of Twelve Thousand Pesos Only (Php 12,000.00) for lot 3 and in the amount of Twenty Two Thousand Pesos Only (Php 22,000.00) for lot 4 and in the amount of Fourteen Thousand Eight Hundred Pesos Only (Php 14,800.00) for lot 5 and to RJ TRANSPORT SERVICES in the amount of Sixteen Thousand Six Hundred Sixty Five Pesos Only (Php 16,665.00) for lot 2.
