Procurement of Supply and Delivery of Goat (by LOT)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Goat (by LOT) (Lot 2) with an Approved Budget for the Contract (ABC) of One Hundred Forty-Four Thousand Pesos Only (Php 144,000.00).

WHEREAS, on Feb. 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers viz: (1) AMARANTE LIVESTOCK TRADING; (2) RVS AGRI PRODUCTS & SUPPLY (3) MIGGY ENTERPRISE

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 27, 2025, AMARANTE LIVESTOCK TRADING, RVS AGRI PRODUCTS & SUPPLY and MIGGY ENTERPRISE submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, AMARANTE LIVESTOCK TRADING is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by AMARANTE LIVESTOCK TRADING in the amount of One Hundred Forty-Four Thousand Pesos Only (Php 144,000.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the Supply and Delivery of Goat (by LOT) (Lot 2) to AMARANTE LIVESTOCK TRADING in the amount of One Hundred Forty-Four Thousand Pesos Only (Php 144,000.00).
