

BAC Resolution No. 0347, Series of 2025

Procurement of Labor and Materials for repair of RP Vehicle NISSAN NAVARRA OY 8607

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Labor and Materials for repair of RP Vehicle NISSAN NAVARRA OY 8607 with an Approved Budget for the Contract (ABC) of One Hundred Twenty-Three Thousand Two Hundred Five Pesos Only (Php 123,205.00).

WHEREAS, on Mar. 31, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ILOILO 3B AUTO PARTS; (2) JRD AUTO REPAIR SHOP; (3) FAUTO CAR SERVICES; (4) REMARD ENGINEERING WORKS & ENTERPRISE

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Apr. 3, 2025, ILOILO 3B AUTO PARTS, JRD AUTO REPAIR SHOP, FAUTO CAR SERVICES and REMARD ENGINEERING WORKS & ENTERPRISE submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation ILOILO 3B AUTO PARTS is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Maygr's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by ILOILO 3B AUTO PARTS in the amount of One Hundred Twenty-Three Thousand One Hundred Eighty-Five Pesos Only (Php 123,185.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Labor and Materials for repair of RP Vehicle NISSAN NAVARRA OY 8607 to ILOILO 3B AUTO PARTS in the amount of One Hundred Twenty-Three Thousand One Hundred Eighty-Five Pesos Only (Php 123,185.00).
