Procurement of Supply and Delivery of Various Vegetable Seeds

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Various Vegetable Seeds with an Approved Budget for the Contract (ABC) of Two Hundred Ninety-Nine Thousand Pesos Only (Php 299,000.00).

WHEREAS, on March 19, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES INC.; (2) ILOILO FAITH ENTERPRISES AND GENERAL MANPOWER SERVICE INC.; (3) JUANTONG AGRI-VENTURE INC..

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. On March 26, 2025, (1) ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES INC.; (2) ILOILO FAITH ENTERPRISES AND GENERAL MANPOWER SERVICE INC.; (3) JUANTONG AGRI-VENTURE INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Various Vegetable Seeds to ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES INC. in the amount of Two Hundred Nineteen Thousand Seven Hundred Eighty Pesos Only (Php 219,780.00).
