One job order for the Printing of SAAD FY 2024 Annual Report and Promisa, The Official Publication of DA-SAAD Western Visayas

WHEREAS, the Department of Agriculture has a Purchase Request for the One job order for the Printing of SAAD FY 2024 Annual Report and Promisa, The Official Publication of DA-SAAD Western Visayas with an Approved Budget for the Contract (ABC) of One Hundred Twenty-Six Thousand Three Hundred Pesos Only (Php 126,300.00);

WHEREAS, on April 4, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) NO BOUNDARIES ADVERTISING AND EVENTS; (2) ILOILO PRINTING AND SERVICES; (3) GILCOR PRINTING PRESS;

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 P.M. on, April 11, 2025, NO BOUNDARIES ADVERTISING AND EVENTS, ILOILO PRINTING AND SERVICES & GILCOR PRINTING PRESS, submitted their quotations;

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, NO BOUNDARIES ADVERTISING AND EVENTS is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number, Income Tax Return, Omnibus Sworn Statement and Brochure

WHEREAS the TWG likewise determined that the financial proposal submitted by NO BOUNDARIES ADVERTISING AND EVENTS in the amount of Ninety-Four Thousand Six Hundred Fifty-Four Pesos & 70/100 Only (Php 94,654.70) is the lowest responsive offeror;


WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found complaint.
