BAC Resolution No. 0260, Series of 2025

Procurement of Supplies for Upscaling of Native Chicken Production

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supplies for Upscaling of Native Chicken Production with an Approved Budget for the Contract (ABC) of Two Hundred Sixteen Thousand Pesos Only (Php 216,000.00).

WHEREAS, on Feb. 6, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) THREE N' ONE ENTERPRISES; (2) NEW HONG CHIU HARDWARE; (3) 3Q CONSTRUCTION SUPPLY; (4) C&T OFFICE & CONSTRUCTION - SUPPLY NON-SPECIALIZED WHOLESALE TRADING; (5) MJBL CONSTRUCTION SERVICES; (6) JUAN TONG & SONS BUILDER CORP.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 13, 2025, THREE N' ONE ENTERPRISES, NEW HONG CHIU HARDWARE, 3Q CONSTRUCTION SUPPLY, C&T OFFICE & CONSTRUCTION - SUPPLY NON-SPECIALIZED WHOLESALE TRADING, MJBL CONSTRUCTION SERVICES and JUAN TONG & SONS BUILDER CORP. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, 3Q CONSTRUCTION SUPPLY is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by 3Q CONSTRUCTION SUPPLY in the amount of One Hundred Twenty-Eight Thousand Six Hundred Eighteen Pesos & 10/100 Only (Php 128,618.10) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOP, for his consideration and approval, the award of contract for the Procurement of Supplies for Upscaling of Native Chicken Production to 3Q CONSTRUCTION SUPPLY in the amount of One Hundred Twenty-Eight Thousand Six Hundred Eighteen Pesos & 10/100 Only (Php 128,618.10).
