WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Vehicle Rental to be used for AMIA Activities with an Approved Budget for the Contract (ABC) of One Hundred Seven Thousand Pesos Only (Php 107,000.00) for lot 1 and Twenty Six Thousand Pesos Only (Php 26,000.00) for lot 2 and Thirty Six Thousand Pesos Only (Php 36,000.00) for lot 3 and Twenty Eight Thousand Pesos Only (Php 28,000.00) for lot 4 and Thirty Two Thousand Pesos Only (Php 32,000.00) for lot 5 and Sixty Eight Thousand Pesos Only (Php 68,000.00) for lot 6.

WHEREAS, on Feb. 4, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) 75Q OPC; (2) EXECUTIVE ELEGANCE CHARTERS, OPC; (3) CHERALD TRAVEL & TOURS; (4) BENNCH TRANSPORT SERVICES

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 11, 2025, 75Q OPC, EXECUTIVE ELEGANCE CHARTERS, OPC, CHERALD TRAVEL & TOURS and BENNCH TRANSPORT SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BENNCH TRANSPORT SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Vehicle Rental to be used for AMIA Activities to BENNCH TRANSPORT SERVICES in the amount of Eighty One Thousand Two Hundred Pesos Only (Php 81,200.00) for lot 1 and Twenty Thousand Six Hundred Pesos Only (Php 20,600.00) for lot 2 and Twenty One Thousand Eight Hundred Pesos Only (Php 21,800.00) for lot 3 and Nineteen Thousand Six Hundred Pesos Only (Php 19,600.00) for lot 4 and Twenty One Thousand Eight Hundred Pesos Only (Php 21,800.00) for lot 5 and Forty Two Thousand Pesos Only (Php 42,000.00) for lot 6.
