WHEREAS, the estimated cost for this Project is Php 339,700.00.

WHEREAS, the Project has been publicized at the PhilGEPS, posted at the PRDP PSO Visayas Bulletin Board and RFQ forms has been issued to various potential suppliers;

WHEREAS, the SBAC has received sealed Quotations from various suppliers for the mentioned Project;

WHEREAS, the SBAC had convened to open and deliberate the quotations of the respective suppliers;

WHEREAS, there were three (3) quotations received as follows:

Name of Supplier **Quoted Price (as calculated)** 1. D' Archbishop Realty Corporation (Hotel Elizabeth) Php 339,700.00 2. Property Specialists Resources, Inc. Php 636,400.00 3. Seda Ayala Center Cebu Php 722,400.00

WHEREAS, of the three suppliers, only D' Archbishop Realty Corporation (Hotel Elizabeth) submitted the complete requirements to include Business Permit (2025), PhilGEPS Registration Certificate (Platinum Membership valid until 24-Jan-2026), Certificate of Registration (BIR Tin) and Affidavit of Bidder on their RFQ, while Property Specialists Resources, Inc. only submitted PhilGEPS Registered (Red Membership since 09-Aug-2012) and Certificate of Registration (BIR Tin) on their RFQ, and lastly, Seda Ayala Center Cebu only submitted Business Permit (2025),PhilGEPS Registered (Red Membership since 28-Aug-2014) and Certificate of Registration (BIR Tin)on their RFQ;

WHEREAS, D' Archbishop Realty Corporation (Hotel Elizabeth), with the quoted price of Php 339,700.00, was found to be the Lowest Calculated and Responsive Quotation which is the most advantageous to the office and the government;
