

WHEREAS, there is a need to enter into Shopping as a mode of procurement considering that the threshold for shopping under PRDP guidelines is \$200,000.00;

WHEREAS, said Procurement was posted in PhilGEPS/ Agency website on April 21-28, 2025, 5:00 PM;

WHEREAS, JMJ CARE CENTER, INC., RED-F AUTO ACCESSORIES SHOP, and DC AUTOWORKZ & AUTO SUPPLY all responded to the Request for Quotation with the following bid offer/ specifications;

WHEREAS, said Establishments are capable Suppliers for the said procurement;

WHEREAS, JMJ CARE CENTER, INC. has the lowest quote with the amount of Php 68,000.00 among the three suppliers but it is worthy to note that they did not quote for two (2) items on their Quotation which resulted in partial bid/quotation;

WHEREAS, RED-F AUTO ACCESSORIES SHOP, has the second lowest quote with the amount of Php 107,272.00 but it is worthy to note that they did not quote for three (3) items on their Quotation which also resulted in partial bid/quotation;

WHEREAS, DC AUTOWORKZ & AUTO SUPPLY, quoted the third lowest price of One Hundred Thirty-Eight Thousand Nine Hundred Twenty Pesos Only (Php 138,920.00) which is advantageous to the government and complies with the specifications and other forms and conditions stated in the Request for Quotations;

WHEREAS, in the Request for Quotation (RFQ) instruction number 10 states that "Awarding shall be done for the whole lot. Partial Bids/Quotations shall not be allowed";

WHEREAS, upon careful examination, evaluation and validation of the quotation offered by the three suppliers, the BAC unanimously decided to disqualify both JMJ CARE CENTER, INC. and

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


