WHEREAS, the I-REAP Component of PRDP PSO-Visayas requested for the Procurement of food, venue, and accommodation for the participants during the Capacity Building (Coaching) on Bookkeeping and Financial Accounting to TAFE and PPMIU Staff of Antique to be held on July 7-11, 2025 in Antique;

WHEREAS, the estimated cost for this Project is Php 96,510.00.

WHEREAS, the Project has been publicized at the PhilGEPS, posted at the PRDP PSO Visayas Bulletin Board and RFQ forms has been issued to various potential suppliers;

WHEREAS, the SBAC has received sealed Quotations from various suppliers for the mentioned Project;

WHEREAS, the SBAC had convened to open and deliberate the quotations of the respective suppliers;

WHEREAS, there were three (3) quotations received as follows:

1. Parvana Inn and Suites	Php 95,220.00
2. Eagle's Hotel and Function Hall	Php 95,850.00
3. Rose Travellers Inn	Php 96,480.00

WHEREAS, of the three suppliers, only Parvana Inn and Suites submitted the complete requirements to include Business Permit (2025), PhilGEPS Registration Certificate (Platinum Membership valid until 14-Sep-2025), Certificate of Registration (BIR Tin) and Affidavit of Bidder on their RFQ, while both Eagle's Hotel and Function Hall and Rose Travellers Inn also submitted the aforementioned documents with the exception of the Affidavit of Bidder on their RFQs;

WHEREAS, Parvana Inn and Suites, with the quoted price of Php 95,220.00, was found to be the Lowest Calculated and Responsive Quotation which is the most advantageous to the office and the government;

WHEREAS, after due deliberation, the SBAC, on MASS MOTION in session assembled:
