

BAC Resolution No. 0455, Series of 2025**Lease of Venue with Food and Accommodation for the conduct of Bantay Peste
Brigade Training for Corn Cluster Areas- Lot 2**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Lease of Venue with Food and Accommodation for the conduct of Bantay Peste Brigade Training for Corn Cluster Areas- Lot 2** with an Approved Budget for the Contract (ABC) of **One Hundred Forty-Seven Thousand Pesos Only (Php 147,000.00)**.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **VILLA CONSORCIA RESORT & RESTAURANT** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
