WHEREAS, there is a need for the Department of Agriculture Regional Field Office No. 6 for the **Community Participation** to be rendered for the **Procurement and Delivery of Coffee for Coffee Production and processing for IP Congress** with an Approved Budget for the Contract (ABC) in the amount of **Fifty Thousand Two Hundred Pesos Only (Php 50,200.00)**.

WHEREAS, Section 35.11 of RA 12009, Community Participation, The Procuring Entity may directly purchase Goods, including agricultural and fishery products from 68 local farmers and fisherfolk, and directly negotiate simple Infrastructure Projects with local communities or social groups (CSG) or members thereof. For this purpose, Community or Social Groups (CSG) may be classified as organized or unorganized.

- a) Organized CSG shall refer to a CSG that has a defined organizational structure, identified membership and leadership, adopts a principle of shared responsibility for their actions and shall be registered with the appropriate regulatory bodies. It shall include Microenterprises.
- b) Unorganized CSG shall refer to a CSG that is not registered with any government regulatory body or a member of a duly recognized private organization, which include, but are not limited to, community labor or pakyaw groups, social enterprises, associations of barangay health workers, farmers, fisherfolk, women, elderly, indigenous peoples, parent-teacher associations, solo parents, and persons with disabilities.

WHEREAS, Nagpana Minorities Association, submits its offer in the amount of **Fifty Thousand Two Hundred Pesos Only (Php 50,200.00)** for the said procurement.

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


