Procurement of Food and Accommodation for Batch 6 of Financial Literacy Training in the Province of Negros Occidental- Lot 6

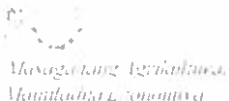
WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food and Accommodation for Batch 6 of Financial Literacy Training in the Province of Negros Occidental- Lot 6 with an Approved Budget for the Contract (ABC) of One Hundred Ninety-Five Thousand Pesos Only (Php 195,000.00).

WHEREAS, on April 4, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers: (1) BACOLOD REAL ESTATE DEV'T. CORP./ACACIA HOTEL BACOLOD; (2) BACOLOD HOTEL/MULTI-LOCK CORPORATION; (3) MAY'S ORGANIC GARDEN RESTAURANT (4) NATURE'S VILLAGE RESORT.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on April 10, 2025, BACOLOD REAL ESTATE DEV'T. CORP./ACACIA HOTEL BACOLOD, BACOLOD HOTEL/MULTI-LOCK CORPORATION, MAY'S ORGANIC GARDEN RESTAURANT and NATURE'S VILLAGE RESORT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, BACOLOD REAL ESTATE DEV'T. CORP./ACACIA HOTEL BACOLOD is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
