**Lease of Venue with Food and Accommodation- RSB SA CY 2025 Midyear
Assessment and Planning Workshop**

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation- RSB SA CY 2025 Midyear Assessment and Planning Workshop with an Approved Budget for the Contract (ABC) of Four Hundred Fifty-Seven Thousand Pesos Only (Php 457,000.00).

WHEREAS, on May 15, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) VILLA CONSORCIA RESORT & RESTAURANT; (2) STA. ANA RESORT; (3) MARIBERT INLAND RESORT.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on May 21, 2025, VILLA CONSORCIA RESORT & RESTAURANT, STA. ANA RESORT and MARIBERT INLAND RESORT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, VILLA CONSORCIA RESORT & RESTAURANT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation- RSB SA CY 2025 Midyear Assessment and Planning Workshop to VILLA CONSORCIA RESORT & RESTAURANT in the amount of Four Hundred Fifty-Six Thousand Pesos Only (Php 456,000.00).
