Lease of Venue with Food and Accommodation

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation with an Approved Budget for the Contract (ABC) of Four Hundred Sixty Thousand Five Hundred Pesos Only (Php 460,500.00).

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
