Lease of Venue - Provision for Food and Accommodation for various Activities

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue - Provision for Food and Accommodation for various Activities with an Approved Budget for the Contract (ABC) of Five Hundred Thirty-Six Thousand Pesos Only (Pnp.536,000.00).

WHEREAS, on May 28, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers: (1) PUNTA VILLA RESORT, INC.; (2) DISTRICT 21 HOTEL; (3) THE CAPITOL PLACE ILOILO INC.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PUNTA VILLA RESORT, INC. is considered as the lowest offeror and with price quotation within the ABC and was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's Business Permit and provision of PhilGEPS Registration Number.


