**Lease of Venue- Food, Venue and Accommodation during the conduct of 2025 SAAD Program 2nd Semestral Physical and Financial Assessment on November 3-6, 2025 at Iloilo City**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Lease of Venue- Food, Venue and Accommodation during the conduct of 2025 SAAD Program 2nd Semestral Physical and Financial Assessment on November 3-6, 2025 at Iloilo City with an Approved Budget for the Contract (ABC) of Nine Hundred Seventy-One Thousand Five Hundred Pesos Only (Php 971,500.00).

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **MO2 WESTOWN HOTEL** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
