Lease of Venue for the Conduct of 2025 Year-end review and finalization of FY 2026 PMED targets on December, 2025 at Iloilo City

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue for the Conduct of 2025 Year-end review and finalization of FY 2026 PMED targets on December, 2025 at Iloilo City with an Approved Budget for the Contract (ABC) of Forty Thousand Five Hundred Pesos Only (Php 40,500.00).

WHEREAS, on June 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION**; (2) **DISTRICT 21 HOTEL**; (3) **SAMS 21 HOTEL**.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
