WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Lease of Venue for the Final Presentation of updated Salt Proposal of Central Antique Convergence Area on June 24 at San Jose de Buenavista, Antique with an Approved Budget for the Contract (ABC) of Twenty-Nine Thousand Nine Hundred Twenty Pesos Only (Php 29,920.00).
