Lease of venue and food during the conduct of RAFC VI 2nd Sectoral Committee Meeting

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of venue and food during the conduct of RAFC VI 2nd Sectoral Committee Meeting with an Approved Budget for the Contract (ABC) of Forty-Two Thousand Pesos Only (Php 42,000.00).

WHEREAS, on June 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION; (2) PARK INN BY RADISSON ILOILO; (3) DISTRICT 21 HOTEL

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on June 19, 2025, ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION, PARK INN BY RADISSON ILOILO and DISTRICT 21 HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, all three suppliers have the same total amount but due to the other two suppliers having no documentary attachments submitted together with their Quotations, their offer shall be rendered invalid. Therefore, ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of venue and food during the conduct of RAFC VI 2nd Sectoral Committee Meeting to ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION in the amount of Forty-Two Thousand Pesos Only (Php 42,000.00).
