

BAC Resolution No. 0480, Series of 2025

Provision of Food and Accommodation during the conduct of Agricultural Information Caravan

WHEREAS, the Department of Agriculture has a Purchase Request for the **Provision of Food and Accommodation during the conduct of Agricultural Information Caravan** with an Approved Budget for the Contract (ABC) of **Two Hundred Thirty-Four Thousand Pesos Only (Php 234,000.00)** for lot 1 and **Two Hundred Sixty Thousand Four Hundred Pesos Only (Php 260,400.00)** for lot 2.

WHEREAS, on May 26, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **KRS CATERING & SERVICES**; (2) **ILOILO PROVINCIAL EMPLOYEES COMMUNITY MULTI PURPOSE COOPERATIVE**; (3) **NUTRENDS CUISINE CATERING** for lot 1 and to (1) **HOTEL VERONICA**; (2) **SAN ANTONIO RESORT**; (3) **ISLAND HOTEL** for lot 2.


WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on May 30, 2025, **KRS CATERING & SERVICES**, **ILOILO PROVINCIAL EMPLOYEES COMMUNITY MULTI PURPOSE COOPERATIVE** and **NUTRENDS CUISINE CATERING** submitted their quotations for lot 1 and **HOTEL VERONICA**, **SAN ANTONIO RESORT** and **ISLAND HOTEL** submitted their quotations for lot 2.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ILOILO PROVINCIAL EMPLOYEES COMMUNITY MULTI PURPOSE COOPERATIVE** is considered as the lowest offeror for lot 1 and **HOTEL VERONICA** for lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Provision of Food and Accommodation during the conduct of Agricultural Information Caravan** to **ILOILO PROVINCIAL EMPLOYEES COMMUNITY MULTI PURPOSE COOPERATIVE** in the amount of **One Hundred Eighty One Thousand Six Hundred Fifty Pesos Only (Php 181,650.00)** for lot 1 and to **HOTEL VERONICA** in the amount of **Two Hundred Fifty Eight Thousand Pesos Only (Php 258,000.00)** for lot 2.
