

BAC Resolution No. 0365, Series of 2025**Procurement of 48 heads Piglets and Feed**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of 48 heads Piglets and Feed with an Approved Budget for the Contract (ABC) of Five Hundred Thirty-Two Thousand Pesos Only (Php 500,332.00).

WHEREAS, on Mar. 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) AMARANTE LIVESTOCK TRADING; (2) GREEN ECO-SOLUTIONS & RESOURCES INC.; (3) MAUSWAGON FARMERS AGRICULTURE COOPERATIVE; (4) YVARRAS GRANJA POULTRY FARM; (5) PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 P.M. on Mar. 25, 2025, AMARANTE LIVESTOCK TRADING, GREEN ECO-SOLUTIONS & RESOURCES INC., MAUSWAGON FARMERS AGRICULTURE COOPERATIVE, YVARRAS GRANJA POULTRY FARM and PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, GREEN ECO-SOLUTIONS & RESOURCES INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PHIGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by GREEN ECO-SOLUTIONS & RESOURCES INC. in the amount of Four Hundred Ninety-Four Thousand Seven Hundred Sixty-Eight Pesos Only (Php 494,768.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of 48 heads Piglets and Feed to GREEN ECO-SOLUTIONS & RESOURCES INC. in the amount of Four Hundred Ninety-Four Thousand Seven Hundred Sixty-Eight Pesos Only (Php 494,768.00).
