

BAC Resolution No. 0403, Series of 2025

Procurement of Works for the Establishment of Animal Housing Facility for Poultry Production (including perimeter and divisional fences)

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Works for the Establishment of Animal Housing Facility for Poultry Production (including perimeter and divisional fences)** with an Approved Budget for the Contract (ABC) of **Five Hundred Ninety Thousand Pesos Only (Php 590,000.00)**.

WHEREAS, on Apr. 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the prospective suppliers related to the said procurement.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Apr. 10, 2025, **B4 CONSTRUCTION DEVELOPMENT AND TRADING CORP.** submitted its quotation.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **B4 CONSTRUCTION DEVELOPMENT AND TRADING CORP.** is considered as a responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **B4 CONSTRUCTION DEVELOPMENT AND TRADING CORP.** in the amount of **Five Hundred Seven Thousand Eight Hundred Ninety Pesos & 25/100 Only (Php 507,890.25)** is a responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Works for the Establishment of Animal Housing Facility for Poultry Production (including perimeter and divisional fences)** to **B4 CONSTRUCTION DEVELOPMENT AND TRADING CORP.** in the amount of **Five Hundred Seven Thousand Eight Hundred Ninety Pesos & 25/100 Only (Php 507,890.25)**.
