Procurement of Light System, Audio System and LED Wall Rental for the conduct of 18th National Corn Congress Visayas Cluster on August 25-29, 2025

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Light System, Audio System and LED Wall Rental for the conduct of 18th National Corn Congress Visayas Cluster on August 25-29, 2025 with an Approved Budget for the Contract (ABC) of Two Hundred Fifty-Five Thousand Pesos Only (Php 255,000.00).

WHEREAS, on Apr. 21, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ARK PRO AUDIO AND LIGHTS; (2) NOYPRO AUDIO AND LIGHTS SUPPLIES AND SERVICES; (3) TRI ADS PRO LIGHTS AND SOUNDS


WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Apr. 28, 2025, ARK PRO AUDIO AND LIGHTS, NOYPRO AUDIO AND LIGHTS SUPPLIES AND SERVICES and TRI ADS PRO LIGHTS AND SOUNDS submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ARK PRO AUDIO AND LIGHTS is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Light System, Audio System and LED Wall Rental for the conduct of 18th National Corn Congress Visayas Cluster on August 25-29, 2025 to ARK PRO AUDIO AND LIGHTS in the amount of Two Hundred Fifty Four Thousand Pesos Only (Php 254,000.00).
