

**BAC Resolution No. 0453, Series of 2025****Procurement and Delivery of Seeds for Production and Livelihood Support**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement and Delivery of Seeds for Production and Livelihood Support** with an Approved Budget for the Contract (ABC) of **Ninety-Nine Thousand Pesos Only (Php 99,000.00)** for lot 1 and **Forty-Nine Thousand Nine Hundred Fifty Pesos Only (Php 49,950.00)** for lot 2 and **Fifty Thousand Pesos Only (Php 50,000.00)** for lot 3 and **Fifty-Five Thousand Pesos Only (Php 55,000.00)** for lot 4.

**WHEREAS**, on Apr. 25, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **RS AGRO INDUSTRIAL CORP.**; (2) **AGRICARE TRADING INC.**; (3) **PLANTERS TRADING AND AGRO SERVICES**; (4) **JUANTONG AGRI-VENTURES, INC.**; (5) **ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.**; (6) **JMD PLANT NURSERY & CONCRETE PRODUCTS**

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 PM. on May 2, 2025, **RS AGRO INDUSTRIAL CORP.**, **AGRICARE TRADING INC.**, **PLANTERS TRADING AND AGRO SERVICES**, **JUANTONG AGRI-VENTURES, INC.**, **ILOILO NEW AGRI-INDUSTRIAL MARKETING AND GENERAL SERVICES, INC.** and **JMD PLANT NURSERY & CONCRETE PRODUCTS** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **RS AGRO INDUSTRIAL CORP.** is considered as the lowest offeror for lot 1 and lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, for lot 3, **JUANTONG AGRI-VENTURES, INC.** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, for lot 4, **PLANTERS TRADING AND AGRO SERVICES** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by **RS AGRO INDUSTRIAL CORP.** in the amount of **Ninety-Nine Thousand Pesos Only (Php 99,000.00)** is the lowest quotation for lot 1 and in the amount of **Forty-Nine Thousand Nine Hundred Twenty Pesos Only (Php 49,920.00)** for lot 2.

WHEREAS the TWG likewise determined that the financial proposal submitted by **JUANTONG AGRI-VENTURES, INC.** in the amount of **Thirty-Four Thousand Five Hundred Pesos Only (Php 34,500.00)** is the lowest quotation for lot 3.

WHEREAS the TWG likewise determined that the financial proposal submitted by **PLANTERS TRADING AND AGRO SERVICES** in the amount of **Forty-Eight Thousand Nine Hundred Fifty Pesos Only (Php 48,950.00)** is the lowest quotation for lot 4.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE,** the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement and Delivery of Seeds for Production and Livelihood Support to RS AGRO INDUSTRIAL CORP.** in the amount of **Ninety-Nine Thousand Pesos Only (Php 99,000.00)** for lot 1 and in the amount of **Forty-Nine Thousand Nine Hundred Twenty Pesos Only (Php 49,920.00)** for lot 2 and to **JUANTONG AGRI-VENTURES, INC.** in the amount of **Thirty-Four Thousand Five Hundred Pesos Only (Php 34,500.00)** for lot 3 and to **PLANTERS TRADING AND AGRO SERVICES** in the amount of **Forty-Eight Thousand Nine Hundred Fifty Pesos Only (Php 48,950.00)** for lot 4.


