

## **BAC Resolution No. 0417, Series of 2025**

### **Procurement of Works for the Establishment of Animal Housing (Native Chicken)- Lot 1 (Brgy. Guinhulacan, Bingawan Iloilo)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Works for the Establishment of Animal Housing (Native Chicken)- Lot 1 (Brgy. Guinhulacan, Bingawan Iloilo)** with an Approved Budget for the Contract (ABC) of **One Hundred Fifty Thousand Pesos Only (Php 150,000.00)**.

**WHEREAS**, on March 25, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **PESOM CONSTRUCTION SERVICES**; (2) **J.C. ALBASON BUILDERS AND SUPPLY**; (3) **GIANTWEST CONSTRUCTION CORPORATION**.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 pm. on April 1, 2025, **PESOM CONSTRUCTION SERVICES, J.C. ALBASON BUILDERS AND SUPPLY** and **GIANTWEST CONSTRUCTION CORPORATION** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **GIANTWEST CONSTRUCTION CORPORATION** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by **GIANTWEST CONSTRUCTION CORPORATION** in the amount of **One Hundred Forty-Three Thousand Nine Hundred Ninety-Nine Pesos and 69/100 Only (Php 143,999.69)** is the lowest quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Works for the Establishment of Animal Housing (Native Chicken)- Lot 1 (Brgy. Guinhulacan, Bingawan Iloilo)** to **GIANTWEST CONSTRUCTION CORPORATION** in the amount of **One Hundred Forty-Three Thousand Nine Hundred Ninety-Nine Pesos and 69/100 Only (Php 143,999.69)**.
