

**BAC Resolution No. 0482, Series of 2025**

**Procurement of Supply and Delivery of Feeds Pellet Machine (Pelleting Machine)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Feeds Pellet Machine (Pelleting Machine)** with an Approved Budget for the Contract (ABC) of **Three Hundred Thousand Pesos Only (Php 300,000.00)**.

**WHEREAS**, on May 6, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **NEW HONG CHIU HARDWARE**; (2) **ADINSO CORP.**; (3) **LB2 LABORATORY SUPPLIES**; (4) **D'MALT INDUSTRIAL SALES CORP.**

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 noon, on May 13, 2025, **NEW HONG CHIU HARDWARE**, **ADINSO CORP.**, **LB2 LABORATORY SUPPLIES** and **D'MALT INDUSTRIAL SALES CORP.** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **NEW HONG CHIU HARDWARE** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by **NEW HONG CHIU HARDWARE** in the amount of **Two Hundred Twenty-Five Thousand Pesos Only (Php 225,000.00)** is the lowest quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Feeds Pellet Machine (Pelleting Machine)** to **NEW HONG CHIU HARDWARE** in the amount of **Two Hundred Twenty-Five Thousand Pesos Only (Php 225,000.00)**.
