**BAC Resolution No. 0514, Series of 2025**  
**(Small Value Procurement)**  
**Procurement of Supply & Delivery of Microbial-based fertilizer**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Supply & Delivery of Microbial-based fertilizer** with an Approved Budget for the Contract (ABC) of One Million Pesos Only (Php 1,000,000.00);

**WHEREAS**, on June 9, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) Iloilo New Agri-Industrial Marketing & Gen. Services, Inc.; (2) Iloilo Faith Enterprises & Gen. Manpower Services, Inc.; (3) Three N'One Enterprises (4) ADA Manufacturing Corp.;

**WHEREAS**, before the lapse of the deadline for submission of quotation at 9:30 A.M. on, June 16, 2025, Iloilo New Agri-Industrial Marketing & Gen. Services, Inc., Iloilo Faith Enterprises & Gen. Manpower Services, Inc., Three N'One Enterprises & ADA Manufacturing Corp. submitted their quotations;

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, Iloilo New Agri-Industrial Marketing & Gen. Services, Inc. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number, Income Tax Return, Omnibus Sworn Statement, SLCC and SEC;

**WHEREAS** the TWG likewise determined that the financial proposal submitted by Iloilo New Agri-Industrial Marketing & Gen. Services, Inc. in the amount of Nine Hundred Twenty-One Thousand Eight Hundred Seventy-Five Pesos Only (Php 921.875.00) is the lowest responsive offeror;

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found compliant.


**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply & Delivery of Microbial-based fertilizer** to Iloilo New Agri-Industrial Marketing & Gen. Services, Inc. in the amount of Nine Hundred Twenty-One Thousand Eight Hundred Seventy-Five Pesos Only (Php 921.875.00).
