

## BAC Resolution No. 0244, Series of 2025

### Procurement of Supply and Delivery of Re-Certification of Biosafety Cabinet and Repair of PCR Chamber

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Re-Certification of Biosafety Cabinet and Repair of PCR Chamber with an Approved Budget for the Contract (ABC) of One Hundred Twenty-Five Thousand Pesos Only (Php 125,000.00).



WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Mar. 5, 2025, LABTRADERS, INC., ESCO PHILIPPINES INC, JAYSON MEDICAL EQUIPMENT REPAIR AND MAINTENANCE SERVICES and BIOSYS MEDICAL TRADING submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ESCO PHILIPPINES INC. is considered as the lowest offeror and with price quotation with n the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by ESCO PHILIPPINES INC. in the amount of Eighty-Seven Thousand Three Hundred Sixty Pesos Only (Php 87,360.00) is the lowest quotation.
