RESOLUTION RECOMMENDING AWARD OF CONTRACT

WHEREAS, the I-REAP Component of PRDP PSO-Visayas requested for the Procurement of Food, Venue, and Accommodation for the participants during the Technical Exposure and Benchmarking for the Cacao and Coconut Farmer and Stakeholders on July 21-25, 2025 in Davao;

WHEREAS, the estimated cost for this Project is Php 301,600.00.

WHEREAS, the Project has been publicized at the PhilGEPS, DA and PRDP Websites, posted at the PRDP PSO Visayas Bulletin Board and RFQ forms has been issued to various potential suppliers;

WHEREAS, the SBAC has received sealed Quotations from various suppliers for the mentioned Project;

WHEREAS, the SBAC had convened to open and deliberate the quotations of the respective suppliers;

WHEREAS, there were three (3) quotations received as follows:

1. Dynasty Management and Development Corp. (Grand Regal Hotel Davao)	Php 301,600.00
2. Davao Excel Ventures Corporation	Php 379,200.00
3. Villa Rosal Beach Resort	Php 433,600.00

WHEREAS, of the three suppliers, only Dynasty Management and Development Corp. (Grand Regal Hotel Davao) submitted the complete requirements to include Business Permit (2025), PhilGEPS Registration Certificate (Platinum Membership valid until 09-Apr-2026), Certificate of Registration (BIR Tin) and Affidavit of Bidder on their RFQ, while Davao Excel Ventures Corporation also submitted the aforementioned documents with the exception of the Affidavit of Bidder on their RFQ, and lastly, Villa Rosal Beach Resort only submitted Business Permit (2025) and PhilGEPS Registration Certificate (Platinum Membership valid until 14-Jun-2026) on their RFQ;

WHEREAS, Dynasty Management and Development Corp. (Grand Regal Hotel Davao), with the quoted price of Php 301,600.00, was found to be the Lowest Calculated and Responsive Quotation which is the most advantageous to the office and the government;
