Lease of Venue-Provision of Food and Accommodation during the conduct of Quarterly DA-Family Information Officers Meeting and Capability Building (Lot 2)

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue-Provision of Food and Accommodation during the conduct of Quarterly DA-Family Information Officers Meeting and Capability Building (Lot 2) with an Approved Budget for the Contract (ABC) of One Hundred Fifty-Four Thousand Pesos Only (Php 154,000.00).

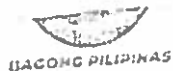
WHEREAS, on May 26, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) MARIBERT INLAND RESORT; (2) HOTEL VERONICA; (3) PALM COAST BEACH RESORT.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon on May 30, 2025, MARIBERT INLAND RESORT, HOTEL VERONICA and PALM COAST BEACH RESORT submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, HOTEL VERONICA is considered as the lowest offeror and with price quotation within the ABC but due to the Non-availability of the Venue on the said date of activities stated in their Technical Specifications, they were found invalid.

WHEREAS, MARIBERT INLAND RESORT is considered as the 2nd lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue-Provision of Food and Accommodation during the conduct of Quarterly DA-Family Information Officers Meeting and Capability Building (Lot 2) to MARIBERT INLAND RESORT in the amount of One Hundred Fifty-Four Thousand Pesos Only (Php 154,000.00).
