

BAC Resolution No. 0466, Series of 2025**Lease of Venue with Food and Accommodation**

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation with an Approved Budget for the Contract (ABC) of Nine Hundred Six Thousand Two Hundred Fifty Pesos Only (Php 906,250.00).

WHEREAS, on May 22, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ROBINSONS LAND CORPORATION (GO HOTELS BACOLOD)**; (2) **O HOTEL/MULTI-LUCK CORP.**; (3) **MO2 WESTOWN HOTEL & CONVENTION HALL**.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on May 28, 2025, **ROBINSONS LAND CORPORATION (GO HOTELS BACOLOD)**, **O HOTEL/MULTI-LUCK CORP.** and **MO2 WESTOWN HOTEL & CONVENTION HALL** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ROBINSONS LAND CORPORATION (GO HOTELS BACOLOD)** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lease of Venue with Food and Accommodation to **ROBINSONS LAND CORPORATION (GO HOTELS BACOLOD)** in the amount of Eight Hundred Seventy-Seven Thousand Seven Hundred Thirty-Nine Pesos Only (Php 877,739.00).


