Lease of Venue for the conduct of Harmonization of performance indicators workshop under FY 2026 GAS targets on September, 2025 in Iloilo City

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue for the conduct of Harmonization of performance indicators workshop under FY 2026 GAS targets on September, 2025 in Iloilo City with an Approved Budget for the Contract (ABC) of One Hundred Fourteen Thousand Seven Hundred Fifty Pesos Only (Php 114,750.00).

WHEREAS, on June 24, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION; (2) DIVERSION 21 HOTEL; (3) DISTRICT 21 HOTEL.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on June 26, 2025, ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION, DIVERSION 21 HOTEL and DISTRICT 21 HOTEL submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ZURI HOTELS AND SUITES/ ZURI HOTELS AND RESORTS CORPORATION is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
