**Procurement of Lease of Venue with Food for the conduct of Provincial Agricultural Stakeholders Forum on July 8, 2025 in the Province of Iloilo**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Lease of Venue with Food for the conduct of Provincial Agricultural Stakeholders Forum on July 8, 2025 in the Province of Iloilo with an Approved Budget for the Contract (ABC) of Fifty-Four Thousand Pesos Only (Php 54,000.00).

WHEREAS, on June 17, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) DISTRICT 21 HOTEL; (2) SENTERA HOTEL VENTURES INC.; (3) PREMIER ISLANDS MANAGEMENT CORPORATION.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on June 20, 2025, DISTRICT 21 HOTEL, SENTERA HOTEL VENTURES INC. and PREMIER ISLANDS MANAGEMENT CORPORATION submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, DISTRICT 21 HOTEL is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Lease of Venue with Food for the conduct of Provincial Agricultural Stakeholders Forum on July 8, 2025 in the Province of Iloilo to DISTRICT 21 HOTEL in the amount of Fifty-Three Thousand Nine Hundred Twenty Pesos Only (Php 53,920.00).


