



BAC Resolution No. 0519 Series of 2025

Procurement of Supply and Delivery of Construction of Mushroom Facility

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Construction of Mushroom Facility with an Approved Budget for the Contract (ABC) of Eight Hundred Fifty Thousand Pesos Only (Php 850,000.00).

WHEREAS, on May 22, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) VILLORENTE TWIN BUILDERS CORP.; (2) FM CONST. SERVICES & SUPPLY; (3) EC BUILDERS.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on May 29, 2025, VILLORENTE TWIN BUILDERS CORP., FM CONST. SERVICES & SUPPLY and EC BUILDERS submitted their quotations:

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, EC BUILDERS is considered as the lowest offeror and with price quotation within the AEC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by EC BUILDERS in the amount of Eight Hundred Forty-Seven Thousand Nine Hundred Ninety-Nine Pesos and 36/100 Only (Php 847,999.36) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HON. DA Secretary, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Construction of Mushroom Facility to EC BUILDERS in the amount of Eight Hundred Forty-Seven Thousand Nine Hundred Ninety-Nine Pesos and 36/100 Only (Php 847,999.36).
