

BAC Resolution No. 0467, Series of 2025

Procurement of Supply and Delivery of Various Laboratory Supplies

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Various Laboratory Supplies with an Approved Budget for the Contract (ABC) of Ninety-Six Thousand Three Hundred Fifty Pesos Only (Php 96,350.00) for lot 1 and Eight Thousand Eight Hundred Pesos Only (Php 8,800.00) for lot 3.

WHEREAS, on Apr. 22, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) THREE N' ONE ENTERPRISES; (2) RICHMART ENTERPRISES; (3) KERR MARKETING

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Apr. 29, 2025, THREE N' ONE ENTERPRISES, RICHMART ENTERPRISES and KERR MARKETING submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, THREE N' ONE ENTERPRISES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by THREE N' ONE ENTERPRISES in the amount of Ninety-Six Thousand Forty Pesos Only (Php 96,040.00) is the lowest quotation for lot 1 and Eight Thousand Seven Hundred Pesos Only (Php 8,700.00) is the lowest quotation for lot 3.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Various Laboratory Supplies to THREE N' ONE ENTERPRISES in the amount of Ninety Six Thousand Forty Pesos Only (Php 96,040.00) for lot 1 and in the amount of Eight Thousand Seven Hundred Pesos Only (Php 8,700.00) for lot 3
