

BAC Resolution No. 0462, Series of 2025

Procurement of Supply and Delivery of Coffee Seedlings

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Coffee Seedlings** with an Approved Budget for the Contract (ABC) of **Two Hundred Seventy-Five Thousand Pesos Only (Php 275,000.00)**.

WHEREAS, on Apr. 25, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **JMD PLANT NURSERY & CONCRETE PRODUCTS**; (2) **NPB PLANT NURSERY**; (3) **DAMIRES HILLS LEISURE FARM TRAINING CENTER INC.**

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on May 2, 2025, **JMD PLANT NURSERY & CONCRETE PRODUCTS**, **NPB PLANT NURSERY** and **DAMIRES HILLS LEISURE FARM TRAINING CENTER INC.** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **JMD PLANT NURSERY & CONCRETE PRODUCTS** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **JMD PLANT NURSERY & CONCRETE PRODUCTS** in the amount of **Two Hundred Seventy-Two Thousand Two Hundred Fifty Pesos Only (Php 272,250.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Coffee Seedlings** to **JMD PLANT NURSERY & CONCRETE PRODUCTS** in the amount of **Two Hundred Seventy-Two Thousand Two Hundred Fifty Pesos Only (Php 272,250.00)**.
