

BAC Resolution No. 04104, Series of 2025**Procurement of Supply and Delivery of Agri Marine and Other Supplies and Materials**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Agri Marine and Other Supplies and Materials** with an Approved Budget for the Contract (ABC) of **Two Hundred Sixty-Eight Thousand Six Hundred Sixty Pesos Only (Php 268,660.00)** for lot 1 and **Sixty-Nine Thousand Nine Hundred Pesos Only (Php 69,900.00)** for lot 2.

WHEREAS, on May 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **KMK AGRI PRODUCTS TRADING**; (2) **ILOILO NEW AGRI-IND. MKTG. and GEN. SERVICES, INC.**; (3) **RS AGRO INDUSTRIAL CORP.**; (4) **JUANTONG AGRI-VENTURES, INC.**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on May 14, 2025, **KMK AGRI PRODUCTS TRADING, ILOILO NEW AGRI-IND. MKTG. and GEN. SERVICES, INC., RS AGRO INDUSTRIAL CORP. and JUANTONG AGRI-VENTURES, INC.** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **JUANTONG AGRI-VENTURES, INC.** is considered as the lowest offeror for lot 1. However, the suppliers offered brand for the item (*Fungicide/ Bactericide, Copper hydroxide (770g/kg), 1kg/pack, Formulation type: WP*) is not compliant to the required specification. Therefore, considered as non-responsive.

WHEREAS, **RS AGRO INDUSTRIAL CORP.** is considered as the responsive offeror for lot 1 and for lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **RS AGRO INDUSTRIAL CORP.** in the amount of **Two Hundred Forty-Nine Thousand Two Hundred Pesos Only (Php 249,200.00)** is the responsive quotation for lot 1 and in the amount of **Fifty-Six Thousand Nine Hundred Fifty-Three Pesos Only (Php 56,953.00)** for lot 2.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Agri Marine and Other Supplies and Materials** to **RS AGRO INDUSTRIAL CORP.** in the amount of **Two Hundred Forty-Nine Thousand Two Hundred Pesos Only (Php 249,200.00)** for lot 1 and in the amount of **Fifty-Six Thousand Nine Hundred Fifty-Three Pesos Only (Php 56,953.00)** for lot 2.
