**BAC Resolution No. 0491, Series of 2025**

**Procurement of Supply and Delivery of Animal Zoological Supplies for 2025**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Animal Zoological Supplies for 2025 with an Approved Budget for the Contract (ABC) of Five Hundred Eighteen Thousand Eight Fifty-Two Pesos Only (Php 518,852.00).

WHEREAS, on May 20, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) MANDALAGAN VETERINARY HOSPITAL & MARKETING; (2) RCM AGRIVET TRADING; (3) PLANTERS TRADING & AGRO SERVICES

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on May 27, 2025, MANDALAGAN VETERINARY HOSPITAL & MARKETING, RCM AGRIVET TRADING and PLANTERS TRADING & AGRO SERVICES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, MANDALAGAN VETERINARY HOSPITAL & MARKETING is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by MANDALAGAN VETERINARY HOSPITAL & MARKETING in the amount of Four Hundred Sixty-Five Thousand Two Hundred Nineteen Pesos & 65/100 Only (Php 465,219.65) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Animal Zoological Supplies for 2025 to MANDALAGAN VETERINARY HOSPITAL & MARKETING in the amount of Four Hundred Sixty-Five Thousand Two Hundred Nineteen Pesos & 65/100 Only (Php 465,219.65).
