

BAC Resolution No. 0520, Series of 2025

Procurement of Various Poultry under the Palayamanan Project in Western Visayas

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Various Poultry under the Palayamanan Project in Western Visayas with an Approved Budget for the Contract (ABC) of Five Hundred Sixty-Nine Thousand Five Hundred Pesos Only (Php 569,500.00) for lot 1 and Three Hundred Forty-Nine Thousand Nine Hundred Thirty Pesos Only (Php 349,930.00) for lot 2.

WHEREAS, on May 23, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) JAMELE POULTRY SUPPLY; (2) PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC.; (3) PACIFICA AGRIVET SUPPLIES

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on May 30, 2025, JAMELE POULTRY SUPPLY, PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. and PACIFICA AGRIVET SUPPLIES submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. is considered as the lowest offeror for lot 1 and lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. in the amount of Four Hundred Eighty Four Thousand Four Hundred Ten Pesos Only (Php 484,410.00) is the lowest quotation for lot 1 and in the amount of Three Hundred Thirty-Six Thousand Five Hundred Sixty Pesos Only (Php 336,560.00) is the lowest quotation for lot 2.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Various Poultry under the Palayamanan Project in Western Visayas to PANAY DARAG CHICKEN BREEDERS ASSOCIATION INC. in the amount of Four Hundred Eighty Four Thousand Four Hundred Ten Pesos Only (Php 484,410.00) for lot 1 and in the amount of Three Hundred Thirty-Six Thousand Five Hundred Sixty Pesos Only (Php 336,560.00) for lot 2.
