

BAC Resolution No. 0602, Series of 2025**Procurement of Supply and Delivery of Machines and Equipment for the DA-AMAD
Operation of One Stop Agribusiness Center (OSAC)**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Machines and Equipment for the DA-AMAD Operation of One Stop Agribusiness Center (OSAC) with an Approved Budget for the Contract (ABC) of Five Hundred Twelve Thousand Pesos Only (Php 512,000.00).

WHEREAS, on July 3, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) ONESTOP CONSUMER GOODS TRADING; (2) HOMEPRINTS COMMERCIAL OPC; (3) SINGLE SEED BAKERY SUPPLIES TRADING; (4) FOODAGRI INNOVATION & TECHNOLOGY HOUSE OPC; (5) RMTS (RELIABLE MODERN TOOLS SUPPLY) CO. LTD.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on July 10, 2025, ONESTOP CONSUMER GOODS TRADING, HOMEPRINTS COMMERCIAL OPC, SINGLE SEED BAKERY SUPPLIES TRADING, FOODAGRI INNOVATION & TECHNOLOGY HOUSE OPC and RMTS (RELIABLE MODERN TOOLS SUPPLY) CO. LTD. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ONESTOP CONSUMER GOODS TRADING is considered as the lowest offeror. However, the suppliers offer for the (Chest Freezer and Chiller) did not met the specification set by the end user.

WHEREAS, a Justification was made by the End-User to accept the offered product of the supplier and that the specification offered will not affect the functionality of the equipment and over all operation of the said product. Thus, the acceptance of the product offered will still be beneficial to the end user's operation for the DA-AMAD Operation of One Stop Agribusiness Center (OSAC).


