**Procurement of Event Production Services and Food on November 18-20, 2025**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Event Production Services and Food on November 18-20, 2025** with an Approved Budget for the Contract (ABC) of **One Million Four Hundred Forty-Two Thousand Five Hundred Pesos Only (Php 1,442,500.00)**;
