BAC Resolution No. (54), Series of 2025

Collaterals to be used during the conduct of CY 2025 Midyear Assessment of DA Locally-Funded Projects on August 11-15, 2025 at Province of Aklan.

WHEREAS, the Department of Agriculture has a Purchase Request for the Collaterals to be used during the conduct of CY 2025 Midyear Assessment of DA Locally-Funded Projects on August 11-15, 2025 at Province of Aklan with an Approved Budget for the Contract (ABC) of Two Hundred Forty-Three Thousand One Hundred Pesos Only (Php 243,100.00).

WHEREAS, on May 27, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) SARAH'S DIGITAL EMBROIDERY; (2) HOMEPRINTS COMMERCIAL OPC; (3) FGS BACOLOD OPC.

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on June 03, 2025, SARAH'S DIGITAL EMBROIDERY, HOMEPRINTS COMMERCIAL OPC and FGS BACOLOD OPC submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, SARAH'S DIGITAL EMBROIDERY is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by SARAH'S DIGITAL EMBROIDERY in the amount of One Hundred Three Thousand Seven Hundred Forty Pesos Only (Php 103,740.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-a-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Collaterals to be used during the conduct of CY 2025 Midyear Assessment of DA Locally-Funded Projects on August 11-15, 2025 at Province of Aklan to SARAH'S DIGITAL EMBROIDERY in the amount of One Hundred Three Thousand Seven Hundred Forty Pesos Only (Php 103,740.00).
