

## **BAC Resolution No. 0542, Series of 2025**

### **Procurement of Catering Services (See Annex for Provisions and venue) (Lot 2 & 3)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Catering Services (See Annex for Provisions and venue) (Lot 2 & 3)** with an Approved Budget for the Contract (ABC) of **One Hundred Twenty-Four Thousand Two Hundred Eighty-Six Pesos Only (Php 124,286.00)** for lot 2 and **One Hundred Eighty-Six Thousand Four Hundred Twenty-Nine Pesos Only (Php 186,429.00)** for lot 3.

**WHEREAS**, on June 27, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **KEATTLE'S CATERING**; (2) **3L PROPERTIES & ALPHA DEVELOPMENT CORP.**; (3) **J&P CANTINA, INC.** for lot 2 and (1) **A&N EATERY**; (2) **MHEALAY'S CATERING SERVICES**; (3) **2STORY KITCHEN, INC.** for lot 3.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 12:00 PM. on July 3, 2025, **KEATTLE'S CATERING**, **3L PROPERTIES & ALPHA DEVELOPMENT CORP.** and **J&P CANTINA, INC.** submitted their quotations for lot 2 and **A&N EATERY**, **MHEALAY'S CATERING SERVICES**, **2STORY KITCHEN, INC.** submitted their quotations for lot 3.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **J&P CANTINA, INC.** is considered as the lowest offeror for lot 2 and **A&N EATERY** for lot 3 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Catering Services (See Annex for Provisions and venue) (Lot 2 & 3)** to **J&P CANTINA, INC.** in the amount of **One Hundred Two Thousand Fifteen Pesos Only (Php 102,015.00)** for lot 2 and to **A&N EATERY** in the amount of **One Hundred Eighty Six Thousand Three Hundred Pesos Only (Php 186,300.00)** for lot 3.
