

BAC Resolution No. 0567, Series of 2025

Procurement of Tokens (for VIPs, facilitators, panelist, RPs) for distribution during the conduct of FY 2025 National Organic Agriculture Congress (NOAC)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Tokens (for VIPs, facilitators, panelist, RPs) for distribution during the conduct of FY 2025 National Organic Agriculture Congress (NOAC) with an Approved Budget for the Contract (ABC) of Seven Hundred Thousand Pesos Only (Php 700,000.00).

WHEREAS, on June 9, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) CAPGEM COMMUNITY MULTI-PURPOSE COOPERATIVE; (2) GOLDEN 8 ENTERPRISES OPC; (3) CUBIXX BUILDERS CORP.; (4) ARTJUANA DESIGNS AND PROMOS INC.; (5) SARAH'S DIGITAL EMBROIDERY

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 PM. on June 13, 2025, CAPGEM COMMUNITY MULTI-PURPOSE COOPERATIVE, GOLDEN 8 ENTERPRISES OPC, CUBIXX BUILDERS CORP., ARTJUANA DESIGNS AND PROMOS INC. and SARAH'S DIGITAL EMBROIDERY submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, SARAH'S DIGITAL EMBROIDERY is considered as the lowest offeror. However, the supplier has no brand offered. Therefore, considered as non-responsive.

WHEREAS, ARTJUANA DESIGNS AND PROMOS INC. is considered as the second lowest offeror. However, it is found to be non-compliant as the supplier still has pending delivery of prior procurement activity on the agency. Therefore, considered as non-responsive.

WHEREAS, GOLDEN 8 ENTERPRISES OPC is considered as the third lowest offeror. However, the supplier did not comply on the required documentary requirements by not submitting an Omnibus Sworn Statement. Therefore, considered as non-responsive.

WHEREAS, CAPGEM COMMUNITY MULTI-PURPOSE COOPERATIVE is considered as the responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NC IV, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Tokens (for VIPs, facilitators, panelist, RPs) for distribution during the conduct of FY 2025 National Organic Agriculture Congress (NOAC) to CAPGEM COMMUNITY MULTI-PURPOSE COOPERATIVE in the amount of Six Hundred Eighty Thousand Pesos Only (Php 680,000.00).
